

He beat two Inter-District bowlers from Lockwood Con on Finals Day and this surprise result showed that there are good bowlers playing outside the top Section.




On Over-80's Finals Day the threatened thunderstorm never really emerged from over the hills at Hemplow but Eddie Hine served up his own lightning performance as he stormed to a first individual title. After dispatching reigning Champion, Denis Iredale 21-16, in the semi-final the Kirkheaton C&BC bowler went on to provide a masterclass of long mark bowling to beat Geoff Rollinson from Holmfirth 21-7 in the Final. Geoff had eliminated last year's beaten finalist, Bill Blackburn from Lindley BC, in the other semi-final to ensure that there was going to be no rerun of last year's Final line-up.

The first team KO competition to be completed this season was the Six-Man's Julie Fuller Trophy which was being contested for the 17th consecutive season, we are very fortunate in having such a supportive and long-standing sponsor. We also have a long-standing winner as well as Longwood (picture overpage) collected the title for the fourth consecutive season when beating Clayton West 63-28 in the Final at Hemplow.

Roll of Honour 2017

We've started compiling the 2017 Roll of Honour and to add to the two individual winners portrayed on the front page of this newsletter we are delighted to add a photograph of the Julie Fuller Trophy winners from Longwood along with our competition sponsor and David Sykes the HDVBA Competition Secretary.

Lindley Lib have won this trophy eight times which is more than any other team the last time being in 2004 but it is 35 years since Netherton won this competition for the only time.

Club Reps Corner

When I was 17 years old I helped form a football team for me and my mates and we entered the local open age league and I took on the role of secretary. We did quite well but got hit by the League for playing an ineligible player in a cup semi-final. Talking to my dad about the problem I pleaded ignorance about the League Rules. He laid in to me telling me that 'as secretary it is your f***ing job to know the rules'.

Ever since then I have taken the rule book of whichever club or League I have been involved with in all sports and spent an hour at the beginning of a new season reading the rules and with red pen highlighting those important ones which are going to get my teams fined and/or thrown out of competitions or lose us league points.

I was reminded of all this recently with the spate of ineligible players in our KO competitions and expulsion or withdrawal of teams due to playing ineligible or unqualified bowlers. Even in the later stages of these competitions we are still finding teams playing bowlers who are not qualified to bowl in these teams.

Three ineligible bowlers in the semi-finals of the Sub-Team KO being the latest transgression of the rules. No-one is suggesting that these are deliberate, in all probability they are ignorance of the rules. These are your rules gentlemen, if you don't like them then change them but don't moan when the League enforces the rules that you have voted in.

An hour making yourself familiar with those rules could save you a lot of embarrassment in front of your club members explaining about how you didn't know the rules when your team has been excluded from a competition. Learn the lesson I learnt as a 17 year-old and in the words of my dad - 'it is your f***ing job to know the rules!'

It is coming around to the time that we review all our League rules and in October we meet to decide any changes that will be made for the start of the 2018 season. Before then clubs have every opportunity to consult on proposed changes with their own members, some clubs choose not to do so. Does yours?


The first pass of proposed changes will be sent to each club by 11 September. Any amendments then have to be received by the General Secretary by 18 September and the formal list of changes to be voted on will then be sent to all clubs by 2 October. Clubs are then expected to consult internally and receive guidance on voting preferences before the Half-Year Meeting which will be held on 16 October.

One of the perpetual proposals to be tabled again this year is the reduction of the bowler qualifying age to 60 from the current 62 years. So what do you think, and equally important, what do your club members think about this proposal?

Inter-District 2017

Our representative team has ended the 2017 season in fourth position of eight teams in the Yorkshire Veteran's League after the final fixture last month. A disappointing end to a campaign where the team was in touch of greater things for most of the season and continues a drop in fortunes over recent years as is shown in the graph below.

On a happier note the same team performed very well to reach the Final of the one-day Hickson Cup tournament held in Leeds this year where they lost out to Bradford who completed a double when lifting the Grouse Trophy for winning the league competition as well. Well done to Bradford, deserving winners.



Competition Secretary's Day

Competition Secretary, David Sykes, has the unenviable task in finding truly neutral greens for our Knock-Out competitions, not only team matches but Individual competitions as well. Normally for team games he has to take in to account location, availability, travelling distance, sponsor's preference and frequency of involved team visits as well as having regard for the last time each team played on that green.

A new consideration has to be included for the Sub-Team KO this year as the sponsors from Croft Care Homes want to bring some of their residents to enjoy the Final so wheelchair access, disabled toilets, cover from the elements and flat routes to the green all have to be added in to the selection process. So next time you have a moan about the neutral green allocated to your game just take a minute to think about the thought that has gone into the decision and take a moment to wonder if you could have done better.

With all that factored in to his thinking, David has gone on to name Brockholes as the venue for the Sub-Team KO on 1 September and that will be followed on 7 September with the Team KO to be held at Broad Oak.

Are we a Male-Only League?

There is nothing in our rules which states that the HDVBA is a male-only competition. But we are, but should we be? That was the question posed in a website based online poll run in early August. Of the 93 votes cast 60 (65%) were in favour of retaining the current male-only status whilst 33 votes (35%) supported the idea of opening up the competition to the ladies as well. That indication is to be further tested next month at the Club's Half-Year Meeting when a proposed rule change will look to insert a new rule stating that the HDVBA is a male-only league.
